Justin is a patient under my care. I saw him on 06/22/2022 at that time he reported mood and anxiety problems due to a prior legal situation he was involved with in 2016. He is currently undergoing attempts to have news stories about the situation redacted as he feels they were inaccurate and this contributes greatly to his stress.

At our appointment he was diagnosed with adjustment disorder and he was referred to therapy. At therapy, he was diagnosed with anxiety and depression. He will continue to work with his counselor in therapy. He indicates he will continue to attempt to have the news coverage and news stories redacted. It is my opinion that if he were to be able to accomplish this, it would benefit him emotionally and help with his recovery.

To Whom It May Concern:

My name is [REDACTED] and I am Justin's Beaton's wife. I live in the city of [REDACTED] and work as an [REDACTED]. Justin and I met while attending [REDACTED] and have known each other well for over 6 years. We were recently married in September 2021.

I was alongside Justin throughout his case, serving his sentence and probation and now the aftereffects of it all. We've discussed the details and evidence at length - I know what did and didn't happen - and I can tell you that what was reported was not an accurate representation. These articles that falsely portray him as a child sexual predator continue to impact him on a daily basis. He has sought counseling through various sources and has been diagnosed with anxiety, depression and adjustment disorder as a result of the information that has been published about him online.

Though he is working to move forward and cope with the challenges in a healthy way, it is difficult when online content is easily accessible by people we meet and interact with in our personal and professional lives. Imagine having content written about you that falsely portrays you as one of society's least desirable characters. Not only that, but it's online and will never go away. This further punishes an individual and does not let them move forward to live a productive life with a steady job and family.

I've witnessed instances where Justin overreacts to people making accusations about him, even simple things like someone saying he got in the way of the base path during a softball game. He tends to be defensive, on edge and suspicious of other people. I believe that these reactions stem from trauma and emotional distress as a result of the articles falsely representing his character.

Justin is very sorry for the inappropriate actions he engaged in and takes full responsibility for those actions, however he is not a child predator or manipulator. He has served the punishment that he was sentenced to and should be allowed to move forward, but the false content that permanently lives online is an unfair continuation of punishment.

Justin has already made such strides to move forward and build a productive life for himself, including marriage, a steady job and service in several areas at our church. The removal of these articles would really help to allow him, and us as a family, to fully move forward.

I kindly ask for your thoughtful consideration in support and encouragement of Justin as you review this petition.

None of us want to be defined by our regrets, and the human side of any story is the consideration we give one another, sometimes even without merit. In this case, however, Justin's life merits consideration. New beginnings and reasonable acts of fairness are bricks laid in the foundation of a civil society.
