

## Media Content Removed




**Overview:** All 22 media outlets were approached, shown the evidence of the facts in the case, and politely asked to remove their coverage. By God's grace, despite a statistically improbable 1% chance, 17 of them generously removed their content. A combination of persistence, consistency, delicate communication, patience, waiting, and, of course, proof to back up the claims all contributed to the monumentally unlikely outcome of getting not just 1 but 17 news outlets to unpublish their news content surrounding Justin's case.

Some were major news outlets, some were data mining sites, and some were hole-in-the-wall or even foreign outfits, but the common denominator was that the contact for each had a compassionate heart and was willing to listen. Justin and his family are grateful to God for that.
